- I hereby register my child in the 2024-2025 DanceLife Studio Season, which runs June 2024 May 2025.
- I agree to pay the annual registration fee of \$30.00 per student for the year. Registration will be renewed at the time of sign up.
- There will be no credits or refunds given for any missed classes. In the event of a regular scheduled class being cancelled by DanceLife Studio for a reason other than scheduled holiday closures or a reason out of DanceLife Studio's control such as weather, a replacement class or rehearsal will be scheduled in the following 30 calendar days. If a student does not attend the replacement class, no additional make-up class will be scheduled
- Monthly tuition will not be prorated for holiday closures or months with more or less days. The studio will be closed on the following dates:

July 4th – Independence Day July 21st-27th – Summer Break September 2nd – Labor Day October 17th & 18th – UEA Break November 27th – 30th – Thanksgiving Break December 23rd - January 3rd - Winter Break January 20th – Martin Luther King Day February 17th – Presidents Day March 31st - April 5th - Spring Break May 26th – Labor Day

- All performing teams will owe a \$40 recital fee for the season. Recital fee is due Sept 1st or at registration for late sign ups.
- Tuition will be due on the 1st of each month. If not paid by the 5th a \$15 late fee will be assessed on the 6th. If my account has a remaining balance on the final day of the month and my credit card cannot be processed, I will be assessed an additional late fee of \$15 each month until paid in full. In addition, I understand that my student will be unable to attend class until the account has a zero balance.
- I understand that I will be required to provide a valid credit card to keep on file. I authorize DanceLife Studio to charge this card in the event that I have a past due balance on my account on the last day of the month. I understand that I will not be given any additional notice prior to the card being charged for the past due balance.
- Tuition is dependent on my child's class hours per week.
- In the event that my check or automatic payment is returned unpaid by my bank, I agree to pay a \$35.00 fee in addition to the amount of the draft or check. I agree that this fee may be collected automatically from my account.
- There will be a charge of \$1.00 per minute that students are late being picked up. This charge will be applied to your account and will need to be paid before the dancer's next class.
- If my child withdraws from classes for any non-medical reason, I will inform the front office within 30 days-notice. If I do not follow this method, my students spot will remain saved in their classes and tuition will continue to be charged to my credit card.
- I understand that costume, recital, and competition fees are non-refundable under any circumstance and I will not receive a refund of any monies already paid. All fees will be due before DanceLife Studio places their orders. If I withdraw prior to costume delivery, I will not receive any costumes.
- I understand that it is my responsibility to continually check my emails, the studio website (www.DanceLifeStudio.net) and my team band app for upcoming events, calendars, studio updates, etc. Notes will NOT be handed out in classes.
- In case suit or action is instituted to collect tuition or any other fees due to DanceLife Studio, the below name promises to pay all collection costs and such additional sums as the court may adjudge reasonable such as court costs, attorney fees, service or process, etc. in said suit or action.
